CONSERVATION CHAMPIONS NAMED



The Northern Neck Land Conservancy's recently awarded its first ever Conservation Champion Award. President of the Northern Neck Land Conservancy, Steve Walker stated, "Tayloe and Helen Murphy are being recognized as leaders in conservation in the Northern Neck and the Commonwealth"

W. Tayloe Murphy Jr., is a former state delegate and state Secretary of Natural Resources, and a local attorney. Helen Murphy is a former president of the Garden Club of Virginia as well as former board member of the Virginia Outdoors Foundation, the Nature Conservancy, the Virginia Historical Society and the Virginia Department of Historic Resources.

In order to protect King Copsico Farm from development, the Murphys donated a perpetual conservation easement in 2001.

Mr. Walker added, "Tayloe and Helen have significantly contributed to conservation in the Northern Neck, not only by conserving their environmentally sensitive property, but also by educating others about the benefits of conservation but also by a lifetime spent educating others about the benefits of conservation".

Pristine Land Conserved at Henry's Island

A Richmond developer has teamed with the Northern Neck Land Conservancy to protect a rare example of Chesapeake Bay maritime forest near the tip of Windmill Point in Lancaster County.

The special environmental characteristic: low dunes and marshes that make the 51-acre parcel so beautiful, also posed environmental concerns that eventually proved too daunting to allow development according to owner Gibson M. Wright.

The easement that Wright has now donated to the con-



servancy vacates eight building lots that had been approved for the property and limits future development on the parcel to one home and outbuildings. A large stand of pines on Henry's Island provides habitat for bald eagles and ospreys; the tract fronts the Chesapeake Bay and contains more than 2,000 feet of forested shoreline along Windmill Point Creek. When members of the land conservancy's board examined the property last month, they spotted bald eagles perched in the pines and numerous southbound migratory plovers and sandpipers feeding on the beach. The tract is designated as "very high ecological value."

The property lies next to a similar 110-acre waterfront parcel that was also protected with an easement recently. Together, the two tracts leave much of the tip of Windmill Point as permanent open space that will never be developed.
